
### Introduction



Thurrock Safeguarding Adults Board (TSAB) works to:



keep adults safe from harm





Our main duty is to try and stop **abuse** and **neglect**.



**Abuse** is when someone hurts you or treats you badly.



**Neglect** is when someone doesn't look after you properly.



Jim is the independent chair of the Thurrock Safeguarding Adults Board (TSAB).



This means he helps run TSAB to help us get better at stopping neglect and abuse.



Every year TSAB writes a report to let people know what we have been doing.



This report describes what we have done to **safeguard** adults with care and support needs.

**Safeguarding** means keeping people safe from neglect and abuse.

# Money

We spent £89,782 (Eighty-nine thousand, seven hundred and eighty-two pounds).




We did not spend all the money we were given this year. We have £71,351 (seventy-one thousand, three hundred and fifty-one pounds) left over.



We will keep the rest to spend next year.

# Safeguarding concerns



There were 1071 **concerns** raised with social care.

A **concern** is when someone is worried that people might be being abused or neglected.



Not all of these needed us to help them.



If Thurrock Council Social Care needed to look in more detail at someone's concern, there would be a safeguarding enquiry. We would support the individual and find out more.



The most common type of concern we looked at was neglect.



The least common type of concern we looked at was **discriminatory abuse**.

**Discriminatory abuse** is when you are treated badly because of your age, sex, gender, race, religion, disability sexual orientation or if you are pregnant.

# Safeguarding adult reviews



A **Safeguarding Adult Review** is when people look at how well local organisations have worked together.



The people doing the review look at what was done and how they can do things better in the future.



They also look at what changes may need to be made to services.



There is only a review when we are sent cases where things went badly wrong.




This year we were not sent any cases where things went badly wrong.

### What have we done?




In 2020 we:

 looked at all of the safeguarding information we had found



 made a new dashboard for the safeguarding information


A **dashboard** is a simple way of showing information on a computer so it is easier to understand.



 finished a project about sexual abuse of young people and adults.
 You can ask to see our action plan about this



 found out more about the people who abuse other people so we can stop them



 found out about young people moving from children's services to adult's services. This will help us understand what we need to do to keep young people safe



 worked with Southend and Essex Safeguarding Adults Boards to write safeguarding information for people who work with adults



 made our website <u>www.thurrocksab.org.uk</u> easier to use for everyone
