Purpose

The primary purpose of the Transition task and finish group is to ensure strategic oversight of the *strengthening safeguarding transitional arrangements* delivery plan which will focus on safeguarding prevention for all young people that move from children to adult services.

Objectives

- To develop a delivery plan identifying the safeguarding needs of young people transitioning from children to adult services.
- To map existing pathways for young people and adults in order to ensure that this work-stream does not replicate or replace existing statutory responsibilities, and to identify gaps or weaknesses in service provision from which to build upon.
- To develop a multi-agency understanding of the issues, resources and pathways.
- To take forward actions/gaps (e.g. a pathway) identified by the mapping/benchmarking exercise.

- To discuss aggregated data in relation to transition between children and adults services in Thurrock in order to develop a picture of the future demand for this pathway.
- To ensure that the products (e.g. a pathway) delivered by this work-stream are created with direct involvement from young people and parents.
- To ensure that Making Safeguarding Personal and Contextual Safeguarding are embedded in policy and practice
- To ensure that best practice is included in the development of the outcomes from the workstream.

Chair

The Chair will be the Principle Social Worker (Thurrock Council).

Membership

Members may nominate a deputy, providing they have sufficient seniority and subject knowledge to make decisions on behalf of their organisation.
